H.E. Bernardito Auza

Archbishop Auza is Permanent Observer of the Holy See to the UN and Permanent Observer of the Holy See to the Organization of American States. A native of the Philippines, he was ordained a priest in 1985 and entered the diplomatic service of the Holy See in 1990. He served in Madagascar, Bulgaria, Albania, the Secretariat of State in the Vatican, and the Permanent Observer Mission of the Holy See to the UN in New York before he was appointed by Pope Benedict XVI as Apostolic Nuncio to Haiti, where he helped in the reconstruction effort after the 2011 earthquake. He returned to the UN in 2014 when Pope Francis appointed him Permanent Observer.



H.E. Mogens Lykketoft

His Excellency is President of the 70th Session of the United Nations General Assembly. At the time of his election on June 15, 2015, Mr. Lykketoft was the Speaker (President) of the Danish Parliament, a position he has held since 2011. Mr. Lykketoft is an economist by training and a veteran parliamentarian and government minister.



His Eminence Vincent Cardinal Nichols

Cardinal Vincent Gerard Nichols is Archbishop of Westminster and President of the Catholic Bishops' Conference of England and Wales. He was elevated to the College of Cardinals by Pope Francis on February 22, 2014 and, after his work fighting human trafficking and modern slavery in London, was asked by Pope Francis, through the Santa Marta Group to help lead a global effort to fight human trafficking.



Commissioner Kevin Hyland

In 2014, the Home Secretary of the United Kingdom appointed Kevin Hyland as the UK's first ever Independent Anti-Slavery Commissioner. The former head of the Metropolitan Police's world renowned Human Trafficking Unit, the Commissioner has over 30 years of experience investigating organized crime and has worked closely with slavery victims to secure a number of key prosecutions of perpetrators. In his role as Independent Anti-Slavery Commissioner, he has spearheaded the UK's fight against modern slavery, with a concerted focus on strengthening law enforcement efforts in the UK and internationally and helping to ensure that public authorities identify and support slavery victims effectively.



Ms. Mira Sorvino

Ms. Sorvino has been a UNODC Goodwill Ambassador for the Global Fight against Human Trafficking since 2009, encouraging the ratification of the Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children, through advocacy work and participation in global and regional events. She carries out field visits and participates in national campaigns on anti-human trafficking related issues, including meetings with trafficking victims to help disseminate their stories and needs. She won an Academy Award and Golden Globe for Best Supporting Actress for her

performance in Woody Allen's Mighty Aphrodite and a Golden Globe nomination for her role in Human Trafficking (2005).



H.E. Lourdes O. Yparraguirre

Ambassador Yparraguirre is Permanent Representative of the Philippines to the UN. She has served in the Foreign Service of the Philippines since 1987 and has represented the Philippines in Austria, Croatia, Slovenia, the Slovak Republic, to the United Nations Office in Vienna, the UN Industrial Development Organization, the UN Office of Drugs and Crime, the Comprehensive Nuclear Test-Ban Treaty Organization, the International Anti-Corruption Academy, and the Atomic Energy Commission.



Ms. Donna Hubbard

A flight attendant for a major commercial airline, she is a Certified Trainer in the fight against Human Trafficking with Airline Ambassadors International. After high school, her life became a series of abandonment, abuse, addiction, gang crime, prostitution, trafficking, rape and violence. She was sold to a pimp and became gang property on the streets of Los Angeles. Her ten years in jails and prisons were the way out, as she discovered the Gospel and started working toward advanced degrees. In 1994, she founded the Woman at the Well Transition Center: a non-profit ministry providing training, workshops and direct services to formerly incarcerated persons throughout the United States and Puerto Rico. They have served over 5,000 men and women since. She became a Pastor in 2000. She was selected to serve on Atlanta Mayor Kaseem Reed's Working Committee to fight prostitution, and sex trafficking in the Greater Atlanta area, and serves as a consultant with the Office of Women's Health addressing trauma impact on women, and best practices in treatment.



Sr. Imelda Poole, IBVM

Sr. Imelda Poole, IBVM, is President of Religious in Europe Networking Against Trafficking and Exploitation (RENATE), a group of Catholic religious congregations from 19 European countries working against human trafficking in Europe, protecting victims, giving safe shelter and working in rehabilitation programs. A native of Great Britain, Poole has worked in Albania for nine years, where she leads Mary Ward Loreto, a non-profit development organization serving vulnerable communities, particularly the Roma.



Dr. James Cockayne

Dr. Cockayne is Head of Office at UN University in New York. He is a strategist, international lawyer and writer, focusing on the role of non-state armed groups in the international arena. He was Co-Director of the Center on Global Counterterrorism Cooperation, leading their work in New York and Africa, and served as Principal Legal Officer in the Transnational Crime and Extradition Units in the Australian Attorney-General's Department; as Chair of the Editorial Committee of the Journal of International Criminal Justice; and as a civil society member of the multi-stakeholder group that established an oversight mechanism for the International Code of Conduct for Private Security Providers. Among other works, he is the author of *Unshackling*

underreported stories, and offers training and media development to strengthen free media globally. Prior to joining the Foundation, she was Managing Director of Reuters Media and Chairman of Action Images and held a number of senior journalistic and management positions at *Agence France-Presse*.



Minister Karen Bradley

Minister Bradley was appointed Parliamentary Under Secretary of State in the Home Office of the United Kingdom and Minister for Preventing Abuse, Exploitation and Crime in February 2014 with responsibilities, among other duties, for modern slavery and violence against women and girls. Prior to her appointment, she was a Conservative MP for Staffordshire Moorlands, and earlier, a Chartered Accountant and Chartered Tax Advisor at Deloitte & Touche and then at KPMG.



H.E. Macharia Kamau

Ambassador Kamau has served as Kenya's Permanent Representative to the UN in New York since 2010 and previously in Nairobi (2009-2010). He served for over 24 years in various senior-level positions within the UN, including senior country leadership and management roles in UNDP and UNICEF in various countries in Africa, the Caribbean and New York. He has also held key special assignments at the UN, including as President of the UNICEF Board (2014), President of UN Forests Forum (2011-2012), Co-Chair of Ad hoc Working Group on Forest Financing (2010-2011), Vice-President of the 67th Session of the UN General Assembly, Co-Chair of Open Working Group on SDGs (2012-2014) and as Co-Facilitator of the Post-2015 Development Agenda (2014-2015). Ambassador Kamau holds postgraduate qualifications from Harvard University with specializations in Macro-economic Policy Management and in Social Policy and Planning.



H.E. Mary Elizabeth Flores Flake

In 2010, Ambassador Flores was the first woman to be appointed as the Permanent Representative of Honduras to the UN. She served as Vice-President of the 67th Session of the UN General Assembly in 2012 and received the "Spirit of the UN" Award for Diplomats from the NGO Committee on Spirituality in 2014. Prior to her appointment to the UN, Ambassador Flores served in the National Congress of Honduras, becoming the first woman and the youngest person to serve as First Vice-President of the National Congress from 2006-2010.



H.E. Juan José Gómez Camacho

In February 2016, Ambassador Juan José Gómez Camacho became the new Permanent Representative of Mexico to the UN. He joined the Mexican Foreign Service in 1988 and served as Head of Mission to the European Union, Ambassador to Belgium and Luxembourg, Permanent Representative to the UN and other International Organizations in Geneva, and Ambassador to Singapore, the Union of Myanmar and Brunei Darussalam.



H.E. Sarah Mendelson

Ambassador Mendelson is the U.S. Representative to the Economic and Social Coun of the UN. She has spent more than two decades working on development, democrated and human rights as a scholar and practitioner both inside and outside of government and has written more than 70 publications. From May 2010 to May 2014, Ambassad Mendelson served as Deputy Assistant Administrator at the U.S. Agency for International Development (USAID), serving as the agency's lead on combatting human traficking. From 2001-2010 and 2014-2015, she worked at the Center for Strategic a International Studies as Senior Adviser and inaugural Director of the Human Rigl Initiative.



H.E. Marcelo Sánchez Sorondo

Bishop Sánchez Sorondo is Chancellor of the Pontifical Academy of Sciences and I Pontifical Academy of Social Sciences in the Vatican. At the express desire of Pc Francis, he has been heavily involved in the Vatican's efforts against human traffickinhosting several events at the Pontifical Academy of Social Science, bringing togetl multi-disciplinary experts. Prior to his 1998 appointments to the Pontifical Academ by Pope John Paul II, he received doctoral degrees in both theology and philosop and taught Philosophy at the Lateran University in Rome and the Free University of Mary of the Assumption in Rome.

"We ought to recognize that we are facing a global phenomenon that exceeds the competence of any one community or country. In order to eliminate it, we need a mobilization comparable in size to that of the phenomenon itself. For this reason, I urgently appeal to all men and women of good will, and all those near or far, including the highest levels of civil institutions, who witness the scourge of contemporary slavery, not to become accomplices to this evil, not to turn away from the sufferings of our brothers and sisters, our fellow human beings, who are deprived of their freedom and dignity. ... The globalization of indifference... requires all of us to forge a new worldwide solidarity and fraternity."
